## GENERAL RULES / PROCEDURES

1. A toss coin shall decide the order of the throw. The winner of the toss will throw first for the bull or waived it. Nearest to the bull will start the game and all the other odd numbered legs. The opponent shall play all the even numbered legs.
2. The dartboard shall be of standard bristle. The height shall be 1.73 meters (5'8") from the center bull to floor level. The minimum throwing distance shall be 2.37 meters (7'9-1/4") from the back edge of the raised toe oche, measured along the floor from the face of the dartboard or 2 meters (9'7.5"), the diagonal distance from the center bull to the back of the raised toe line.
3. The "Bust" rule will apply i.e. if you scored more than required, you revert back to the score required prior to opponent's last throw.
4. All other rules and regulations pertinent to the '01' mode of play shall be interpreted and enforced by the tournament committee.
5. No darts are to be retrieved from the dartboard until the score has been recorded by the scorer/referee (if any) or the players themselves. Protest after retrieval of a dart may not be accepted.
6. The score is counted from the side (point of entry) of the segment wire where the dart enters and remains in the dart board.
7. Dress code - All players shall wear respectable playing attire: Shorts, slippers, sleeveless shirt and jogging pants are not allowed. Smoking and drinking of liquor is strictly prohibited within the designated playing area.
8. Any protest must be lodged with the match board referee or tournament committee, at the time of the alleged violation, a judgement must be given on the spot, before the leg, set or match is allowed to continue. Any late protest will not be honored.
9. Players / Team Manager and Captain are required to report to the Tournament director 20 minutes prior to the scheduled starting time of the match for each event.
10. Any player not in attendance when called to the control desk for their matches will be defaulted. Only ten (10) minutes will be allowed from the time an opposing player reports to the control desk of the appearance of his/her opponent.
11. Participating player's failing to report to the tournament director by the notified time will be eliminated from the competition.
12. At the Control Desk, the player or the team manager must collect the score sheet for the match, which is to be handed over to the scorer/referee (if any) at the assigned board. The scorer/referee will complete such score sheet, which is to be returned by the winner to the control desk after the match.
13. Player must present their identification card/badge when required during match and/or registration.
14. Each player is entitled to six (6) darts to be thrown at the assigned match board as practice darts prior to start each match.
15. No practice dart is allowed on an unassigned dart board after the competition has started.
16. No person/ darter will be allowed in the playing area other than the assigned players, scorer/ referee, and recorder.
17. All matches and games will take place at the designated official board/ venue.
18. Any player found guilty of deliberately losing a game shall be disqualified and barred from joining the tournament.

All matters pertaining to Philippine Open Singles 2010-Ladbrokes.com World Darts Championship 2010 tournament shall be under the supervision and direction of QII and DCP. All rules apply as laid down by the Darts Regulation Authority (DRA) of London England and the DCP.

Interpretation of the DRA code of conduct and playing rules by the organizer and its appointed officials shall be FINAL and BINDING.
